
















Gaithersburg West Master Plan Open Space Network – Urban Connectors



Draft Transportation Recommendations

LSC Area Transit Services

- Realign CCT to serve LSC, PSTA & Belward
 - Stations are focal point for evolving mixed-use communities
 - CCT bridges possible over Key West Ave & Great Seneca Highway
 - LRT/BRT decision Spring 2009
- Develop express bus service from I-270, ICC
- Develop circulator transit services




