



Existing Park and Recreation Facilities




Major Park and Recreation Users

- Hillandale Neighborhood




Constraints

- Stream Valley Parks: steep and sensitive
- **Pedestrian Restrictions**
 - Colesville Road/Rte 29
 - New Hampshire Ave/Rte 650
- FDA / GSA: no public access
- **Traffic Congestion**
- Lack of Transit
- Lack of Street Connectivity



Preliminary Objectives


- Provide park and recreation opportunities in areas of highest density
 - FDA9,000 employees
 - Cherry Hill Rd Employment Area
 - Redeveloping Shopping Centers
- Create Walking and Cycling Connectivity
 - Link two sides of Paint Branch stream valley
 - Link Planning Area to Martin Luther King Recreational Park
 - Link Planning Area to regional trails and bikeways
 - Create loop systems in areas of highest density

- Link to Cherry Hill Road bikeway




Policy Guidance

1997 White Oak and Fairland Master Plans: Accomplished or Underway

- Recreation Center and April-Stewart Lane Local Park.
- Martin Luther King Recreational Park Outdoor Pool.
- Designate the Northwest Branch and Paint Branch stream valley parks as greenways that provide continuous north-south corridors for humans and wildlife.
- Evaluate the potential to expand and improve the recreation facilities at Hillandale Local Park.
- Acquire second building and encourage renovation and reuse of Northwest Branch/Morse Historic Complex (WSSC Building and its twin at Northwest Branch and US 29)
- Acquire and develop Stonehedge Local Park with youth soccer field, basketball court, and playground. Seek direct connections to Industrial area and Paint Branch.
- Improve the trail network in the Northwest Branch stream valley south of Randolph Road to protect the sensitive and high quality natural resources in the area and to provide for recreation use.





Policy Guidance

1997 White Oak and Fairland Master Plans: Still to do

- Enhance the Paint Branch and Northwest Branch Stream Valley Parks trail system to provide better access and connection to the adjoining communities and neighborhoods.
- Expand recreational access between natural areas and neighborhoods while protecting and restoring stream valley habitat.
- Extend Paint Branch trail from Martin Luther King Park to Old Columbia Pike. An
 additional spur connection from the new bridge to the public easement off of Cedar
 Hill Drive (Rolling Acres).

Status – Amendment to Countywide Park Trails Plan currently underway will develop methodology for deciding when the need for a trail is great enough to outweigh the environmental and financial costs of trail construction in sensitive areas.





Policy Guidance


Vision 2030 Strategic Plan (2010)

- East County area has higher level of service overall than North Central and South Central when normalized for population.
- Top 10 Priorities to add, expand or improve*: Trails, Natural Areas, Playgrounds, Community Recreation Centers, Indoor & Outdoor Aquatic Centers, Fitness Space, Performing Arts Space, and Athletic Fields.
- Amenity Recommendations:
 - Consider repurposing underutilized tennis courts
 - Maintain high level of service for playgrounds
 - Strategic potential to add picnic shelters, athletic fields, skate parks, dog parks, volleyball.
 - Expand trails in densely populated areas







Team Area Athletic Fields

Park Recreation and Open Space (PROS) – 2005 Land Preservation, Parks, and Recreation Plan (LPPRP)

- Estimated Needs to 2020
 - Countywide: 21 picnic shelters, 2.3 nature centers, 16 skate parks, 15 dog parks, 11.5 community recreation centers, 4 aquatic facilities, trails per Countywide Park Trails Plan
 - Team Area: 4.8 large multipurpose rectangular fields
 - Community: 0 basketball or tennis courts, 0 playgrounds





Enjoy but not destroy environmentally sensitive areas

- Locate hard surface routes ☐ Outside of sensitive areas
- Locate natural surface trails
 - ☐ With loops and spurs
 - ☐ In less constrained areas
 - ☐ In existing impacted areas
- Connect to bikeways
 - Locally
 - ☐ To PG County system
- Locate new parks and open spaces
 - ☐ Adjacent to existing parkland
 - ☐ Central to areas of highest density
 - Where there are opportunities
