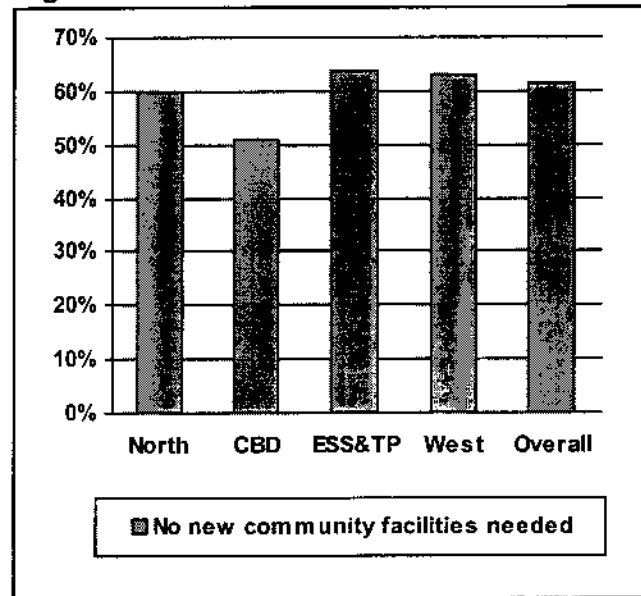


## CHAPTER 4

# COMMUNITY FACILITIES

- The majority, 61 percent, reported that there were **no** new community facilities that they would like to have in their neighborhoods. Among those who wanted new facilities, there was no clear mandate. The strongest support was for new parks, 9 percent. The area most interested in more parks was the CBD, 12 percent, followed by a community center, 7 percent. As an older area of the County, Silver Spring/Takoma Park appears to have the basic public facilities in place.

### Additional Community Facilities Needed by Moving Status

- A slightly higher percentage of those who plan to remain in their current homes for more than two years said they think that no new community facilities are needed. Sixty-six percent of non-movers did not suggest new facilities, compared to 61 percent of those who plan to move. There was no appreciable difference between two groups in the facilities mentioned by those who offered suggestions, however. Parks and a community center remain the leading suggestions. Support for a library is higher among non-movers than movers but is still very low. Potential movers had more demands and suggestions than non-movers, indicating that part of their motivation to move may be to obtain additional facilities. (This was an open-ended question and respondents were not responding to lists of specific facilities.)

## Improvements to Parks

- *More than half of the respondents, 55 percent, indicated that there were no specific improvements they would like in the area's parks.* "Better park maintenance" was the most popular improvement mentioned, 13 percent of the respondents. Another 9 percent suggested "improved security." No other suggestion received more than 5 percent of the responses, although there were some interesting and practical recommendations, such as areas specifically for dogs, completion of the Capital Crescent Trail, and organized activities for elementary school age children. There were no significant differences among the planning areas.

- *Eighty-two percent said that they were familiar with bike and walking trails in the parks in their community.* Sixty-one percent report that they use them. North Silver Spring residents are the heaviest trail users, 66 percent. CBD residents use them least, only 42 percent say they do.

One series of questions addressed Sligo Creek Park specifically:

- *Ninety-one percent of the respondents said that they are familiar with Sligo Creek Park.* Of these, 62 percent report using the park and its facilities. Among the 29 percent who are familiar with the park but do not use it, 29 percent said they are not close enough, 21 percent said they do not have enough time, and 18 percent said they are not interested. North and West Silver Spring residents were particularly likely to say they were too far away, 38 percent and 43 percent respectively. CBD residents were least likely to know about the park; 14 percent were not familiar with it. CBD residents were also most likely to plead no time to use it, 28 percent. While 70 percent of East Silver Spring and Takoma Park residents use the park, those who do not say distance, 24 percent, and lack of interest, 25 percent, are their reasons.

- *More than half, 56 percent, of respondents believe that bike and pedestrian access to Sligo Creek Park is adequate but 36 percent say it needs improvement.* West Silver Spring residents most often said access needs to be improved, 53 percent. Because of their distance from the park, they may mean that they need better bike and pedestrian links to the park from their neighborhoods rather than better direct entrances to the park. While a majority do not think there are access problems, the percentages of those suggesting improvements are probably high enough to warrant further study.
