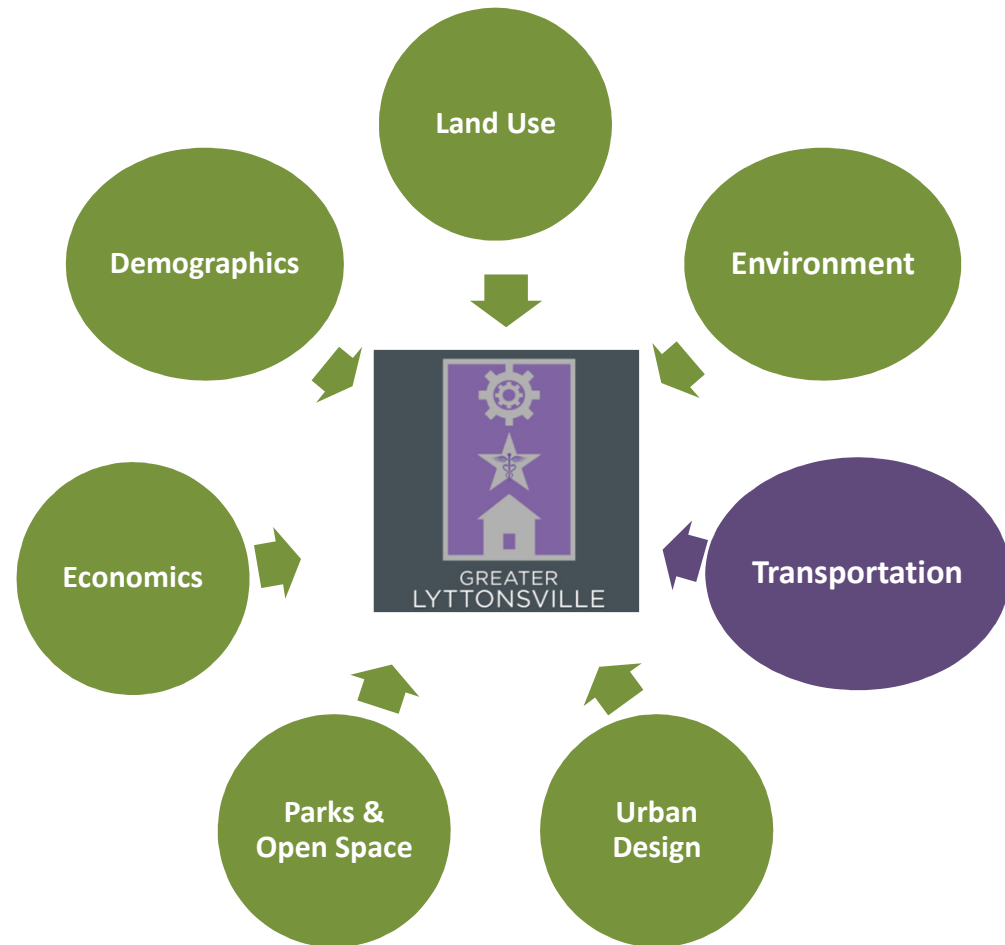

Good planning is sustainable:

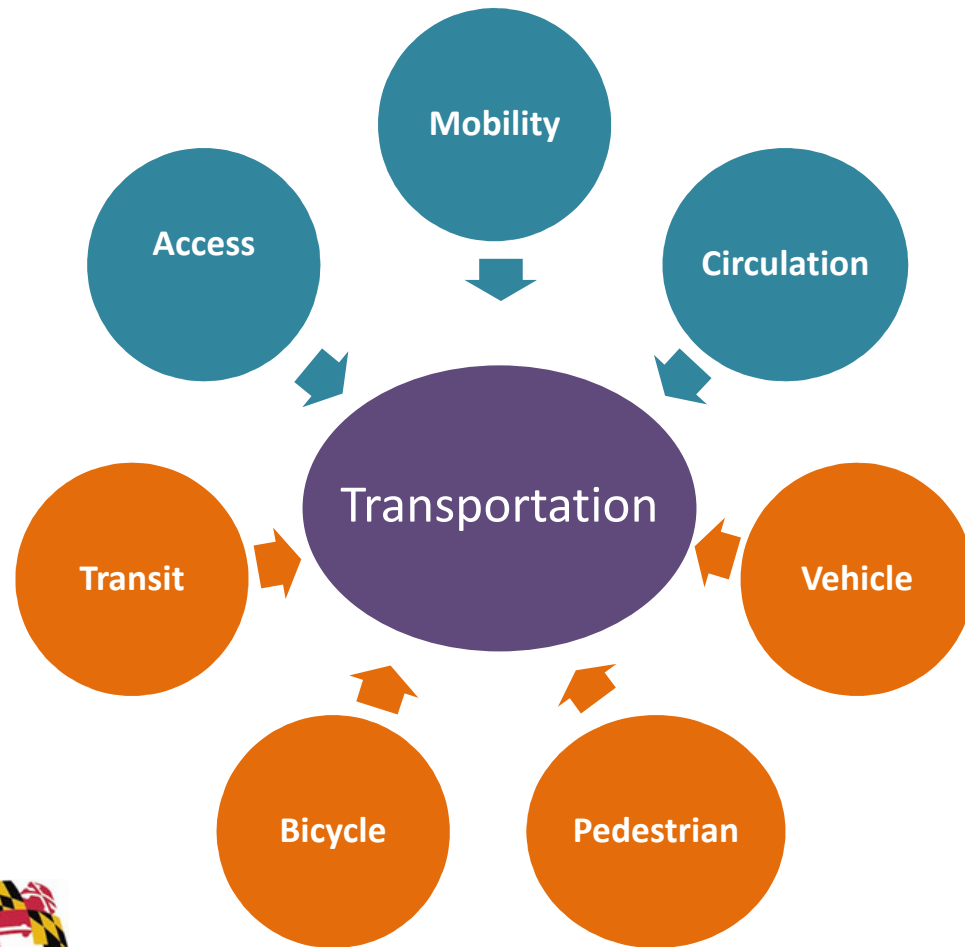
- Social equality

- Mandatory Referral



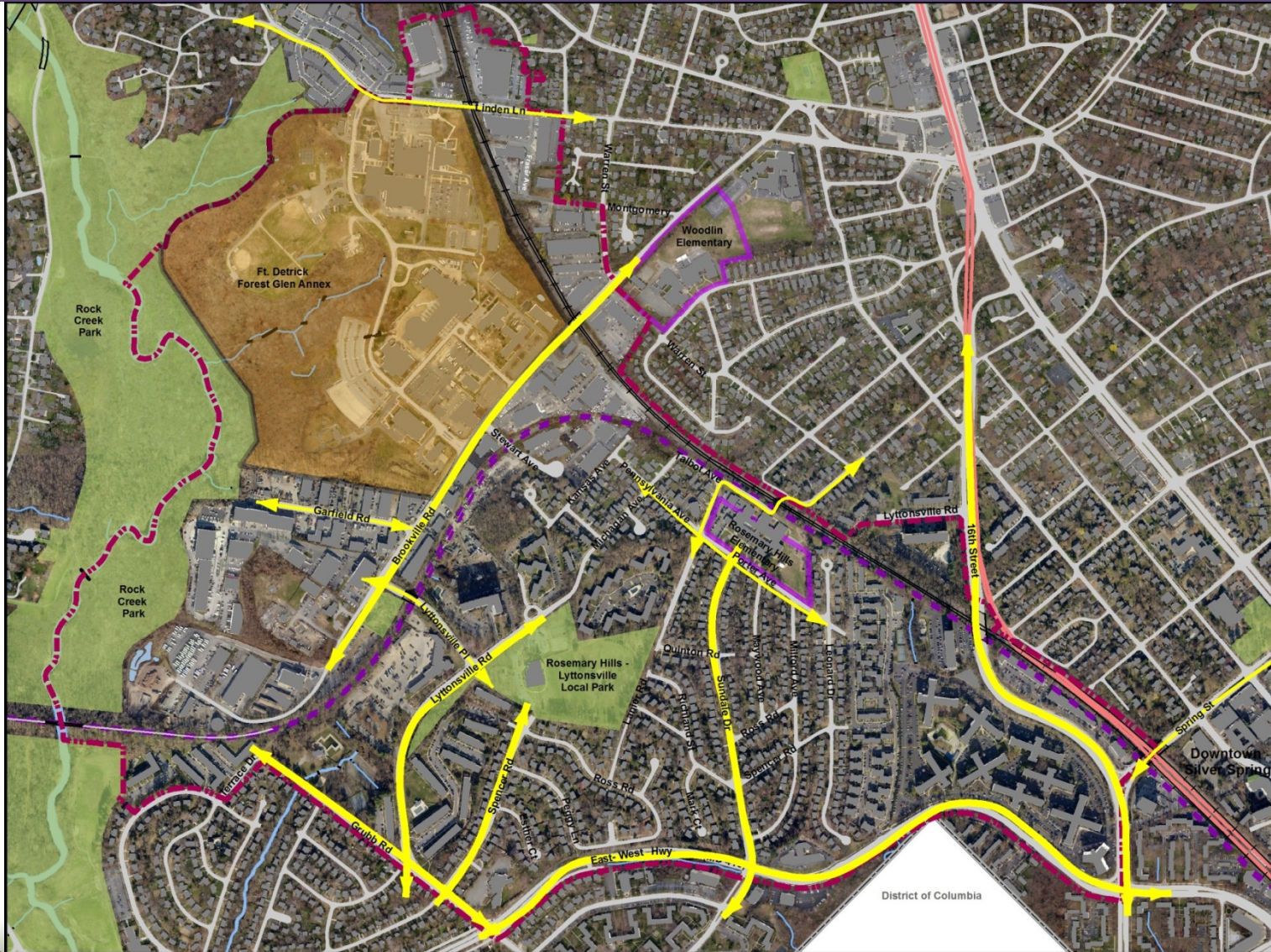

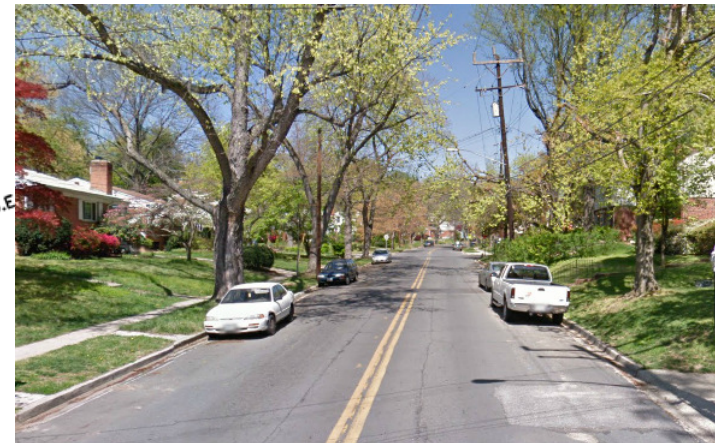

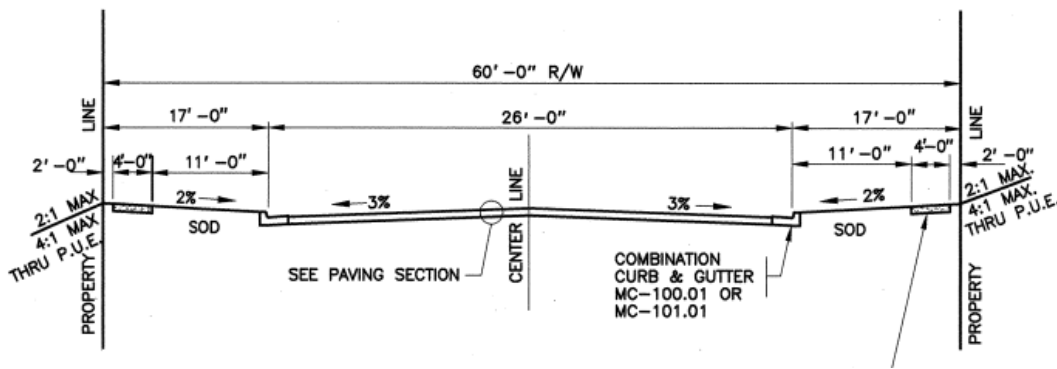

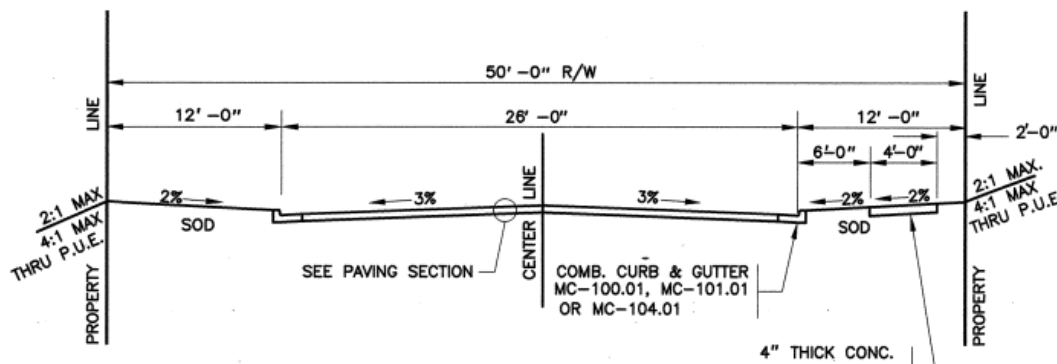

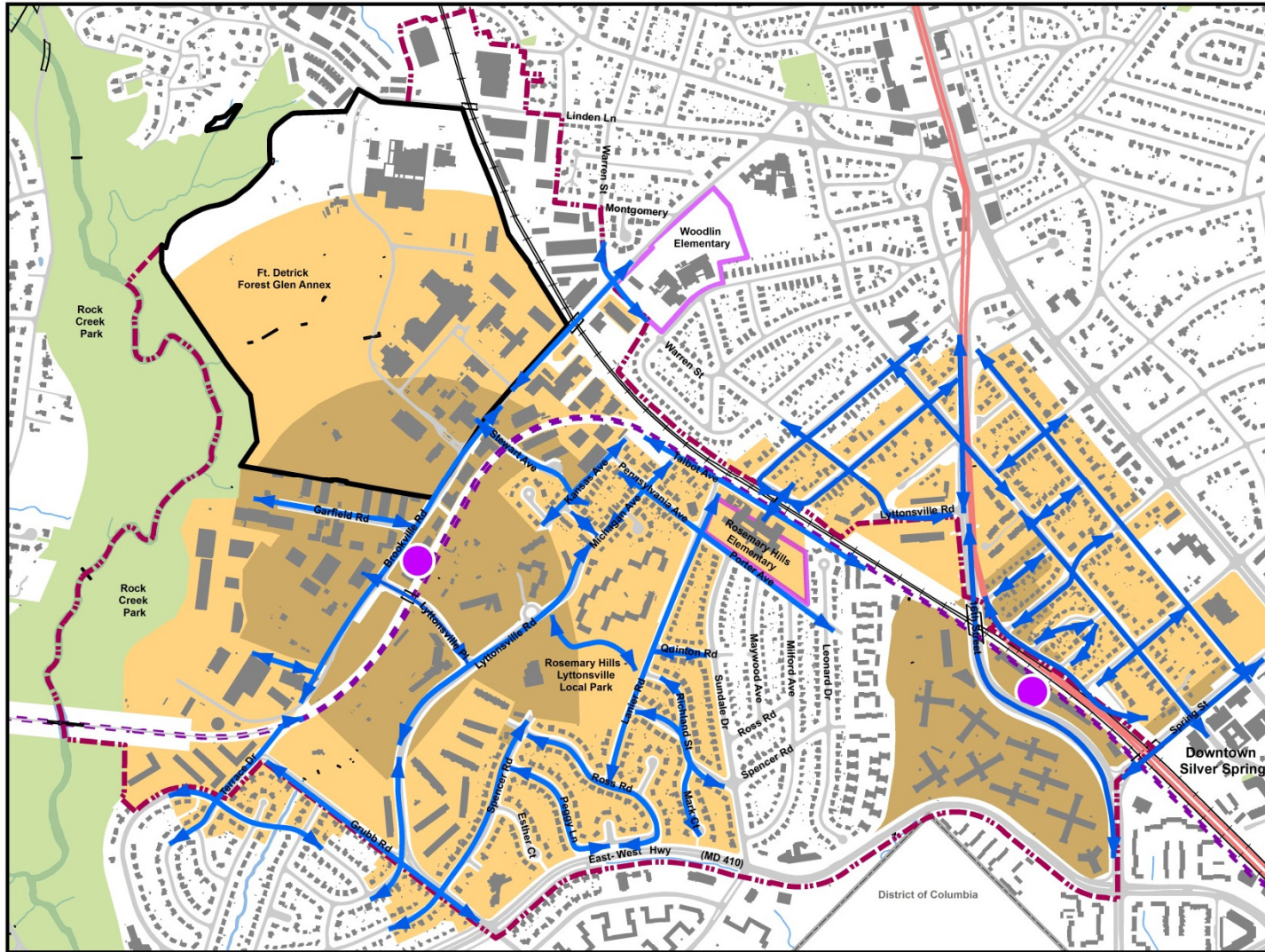

- Land Use Forecasts (households and Jobs) in 2040

### Outputs

- Traffic Volumes at Intersections in 2040



# Continued Research & Analysis: Traffic Forecasting

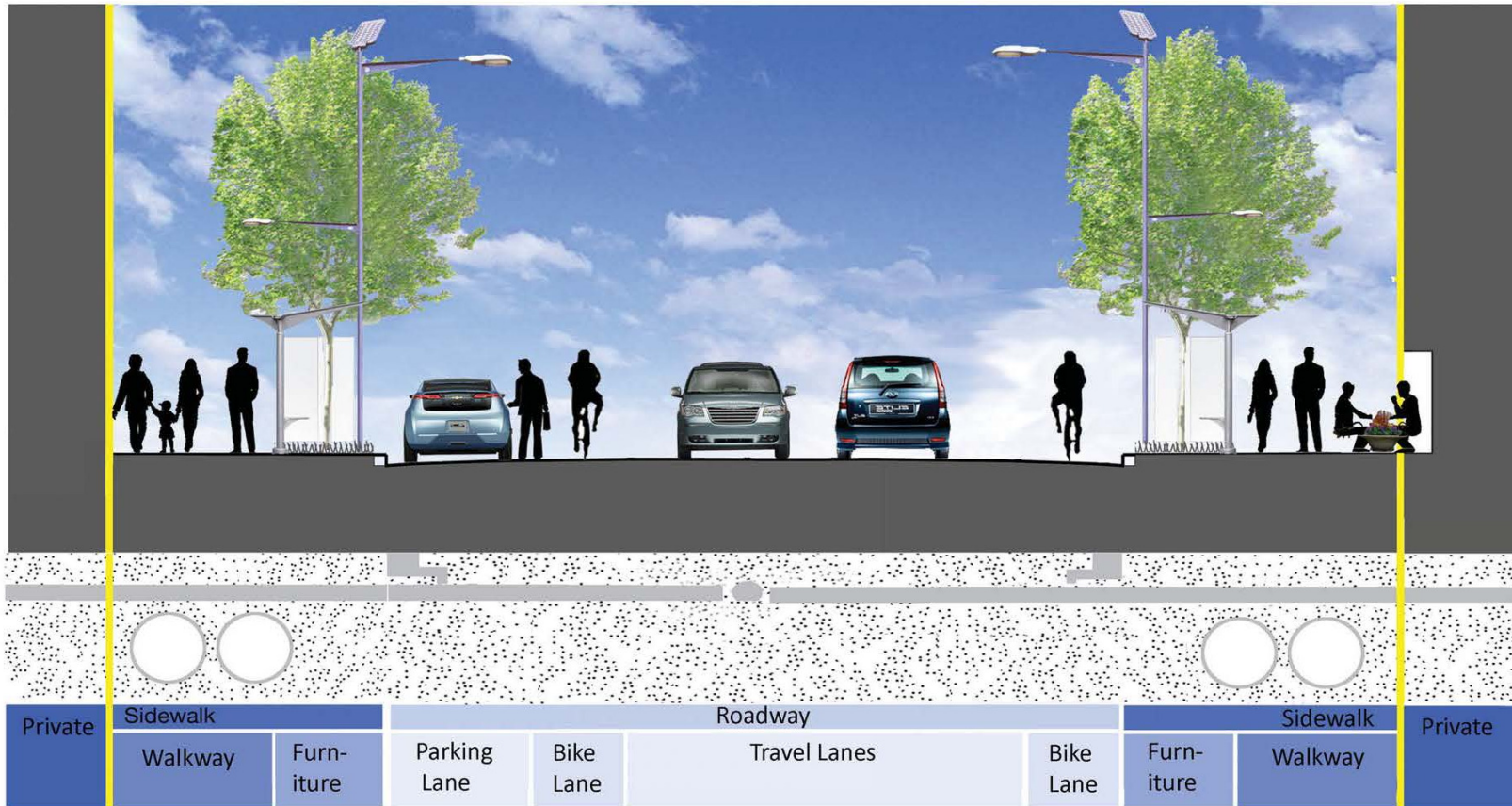

## Measures of Congestion

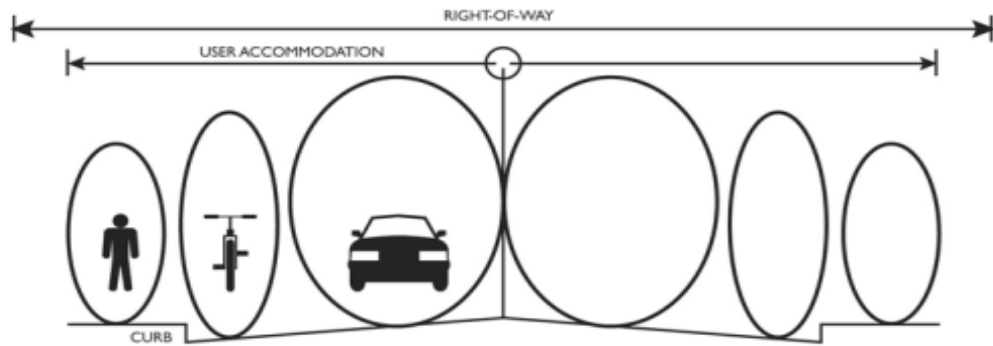
- Peak Hour (Morning and Evening)
- Critical Lane Volume (CLV)
  - The sum of traffic volumes that cross at a single point of an intersection
  - Planning Tool
  - CLV Standard in the Silver Spring/ Takoma Park Policy Area: 1,600
- Highway Capacity Manual (HCM)
  - Conducted if CLV exceeds 1,600
  - Intersection Volume/ Capacity (V/C)
  - V/C Standard in the Silver Spring/ Takoma Park Policy Area: 1.0

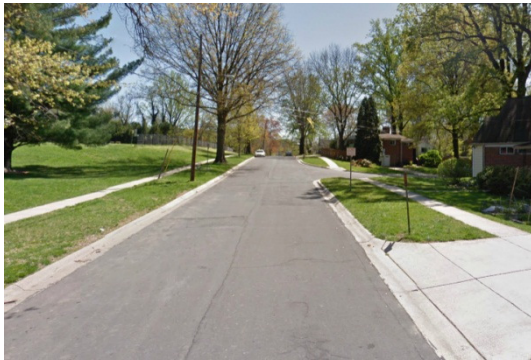
