Subject: Upper Patuxent Resources -- Required Final Update to DPS Records of Historic Properties

Ms. Lucas,

On Tuesday, September 18, 2012, the County Council introduced and adopted Council Resolution 17-538, approving with revisions the Planning Board Draft of the Upper Patuxent Area Resources, an Amendment to the Master Plan for Historic Preservation. One district and 10 sites were designated on the Master Plan for Historic Preservation.

Attached is the Upper Patuxent Final Status Summary Table, which shows the final status of all the evaluated resources, with resource numbers, addresses, and associated tax account numbers and public right-of-way.

All shaded properties in the table were designated on the Master Plan for Historic Preservation and are subject to the requirements of MCC Article 24A. Historic Resources Preservation.

All properties that are not shaded in the table were not designated on the Master Plan for Historic Preservation, were removed from the Locational Atlas, and are not subject to the requirements of MCC Art. 24A.

Would you kindly update your historic property records accordingly for these 95 tax parcels. We will update our GIS records as well.

Please note that some resources include tax parcels with no street address, so you will have to keep track of them by tax account number. For example, the individual site known as 15/8-1 Montgomery Chapel Methodist Protestant Church and Cemetery is made up of three parcels and parts of two rights-of-way. The three parcels each have separate owners, and two of these parcels have no street address. (And note, this resource was evaluated both as part of a district that was not designated and as an individual site, which was designated, so be sure to record it as a designated property in your records.)

Would you kindly update your records as soon as possible.
2. Also, please further update your records by adding and removing Locational Atlas resources as follows:

- 15/117 Mt. Lebanon School/Site of Mt. Lebanon Methodist Episcopal Church, 26310 Mullinix Mill Road (Tax Parcel 12-00938503)

(Added to Locational Atlas by Planning Board at its 3rd and last worksession for the Upper Patuxent Area Resources Amendment to the Master Plan for Historic Preservation, held on 2.10.2011)

- 15/1 Parr's Spring, 4704 Old National Pike (Carroll County Tax Parcel 13-002061/Montgomery Tax Parcel U-81018)

(Listed on the original 1976 Locational Atlas and still listed, but not shown in your Montgomery County Department of Permitting Services Historic Properties Report dated 5.23.2011, which you sent to Joshua Silver on the same date) –

Parr's Spring is the designated boundary point for four counties (Frederick, Montgomery, Howard, and Carroll), and a boundary stone, now within in a pond formed by the spring, marks the location. It is located at the northeastern tip of Montgomery County on a property taxed by Carroll County but actually containing land in four counties, including Montgomery County.
